The meeting was held at Palmers Green Mosque and Mohammad Tariq Sediq was thanked for hosting the meeting and providing a wonderful spread of refreshments. Members were reminded that it was good to have the meetings at different places of worship or at a School.

Clerk's note: Father Vince Sheehan chaired the meeting as Vice-Chair from this point of the meeting.

**RESOLVED** to agree to the above absences.

The Enfield SACRE recognised the importance of members' attendance at meetings to ensure that the essential work of the SACRE is completed effectively. If individual members find it difficult to attend meetings, they may wish to consider whether an alternative member of their community would be able to take on the role. Please remember to provide

apology of absence to Felicia Ferraro, the Clerk if you cannot attend a meeting.

There was a good turnout of members of each group so the meeting was quorate.

Clerk's note: Mohammad Tariq Sediq advised that he needed to leave the meeting for a short time at 6.30pm for evening prayers.

# 2. <u>MEMBERSHIP AND WELCOME</u>

The Vice-Chair welcomed members and Observer, Panos Fellas, Chair of Watford Area Humanists.

(Reminder: the Constitution was changed and agreed at the meeting on 10 February 2025.

Panos Fellas was currently on the Barnet SACRE and had contributed to their new, revised RE syllabus last year. He was also the Chair of Watford Area Humanists and an accredited School Speaker on humanism. He lived in Enfield for many years before the teaching job took him to Bushey, near Watford.

Clerk's note: due to an oversight at the meeting, Chair's action took place so that the appointment of Panos Fellas, Humanist could be ratified by SACRE members.

All members were asked to kindly introduce themselves.

# (a) Appointments

#### **REPORTED**

- (i) the new appointment of Cllr Mahym Bedekova (to replace Cllr Destiny Karakus (as below). Members welcomed Cllr Mahym Bedekova to the meeting.
- (ii) that Rabbi Dany Rich emailed Felicia Ferraro (Clerk) on 19 May 2025 to advise that as of the following day he would be elected Mayor of the London Borough of Barnet. In light of that Rabbi Danny Newman was to replace him and become representative from Southgate Progressive Synagogue (SPS) Progressive Judaism. Rabbi Danni Rich would remain the Senior Rabbi.

Members welcomed Rabbi Danny Newman to the meeting.

# (b) Resignations

#### NOTED

(i) the resignation of Cllr Destiny Karakus received via email on 10 February 2025. Cllr Mahym Bedeokova was to replace Cllr Destiny Karakus.

(ii) Cllr Mahym Bedeokova advised that as some of her other meetings she was committed to also took place on a Tuesday, she might not always be able to attend meetings.

# (f) <u>Vacancies</u>

# (i) Chair

**REPORTED** that Cllr Destiny Karakus had recommended Cllr Mahym Bedekova to be considered as Chair of SACRE. However, due to a high number of other commitments taking place on a Tuesday it was very difficult.

Therefore, following some discussion Cllr Emma Supple was asked if she would consider being Chair, with full support from the Clerk and members.

**RESOLVED** that Cllr Emma Supple be elected Chair of SACRE with effect from 10 June 2025. Proposed by Cllr Bedakova, seconded by Father Vince. A vote took place by all SACRE members.

Clerk's note: Cllr Emma Supple was thanked and chaired the meeting from this point.

# (ii) Members

**NOTED** that there continued to be a high number of vacancies on SACRE, at present count 16. See full membership details which were attached with the agenda and supporting meeting documentation emailed by the Clerk for the 10 June 2025 meeting.

#### **Quaker Representative**

Lucy Nutt confirmed that contact had been made via email on 3 March 2025 to invite Jeremy Marrs-Grant who had been appointed to Winchmore Hill Quakers to the SACRE meeting. The Clerk also followed up with another email on 12 May 2025 but unfortunately no response had been received.

## **Baptist Representative**

Nick Chanda had emailed Lucy Nutt and the Clerk on 11 February 2025 advising that the Baptist Church had a person available to fill the SACRE vacancy. The Clerk emailed Nick Chanda asking for their full details to be sent in order that they could be invited to the next meeting as an Observer, but no further details were forwarded to the Clerk.

Clerk's note: Once Nick Chanda joined the meeting, a discussion took place after the meeting with Nick and the Clerk and details were going to be forwarded to the Clerk accordingly.

**RESOLVED** that trying to appoint more members continued to be pursued. It had been discussed and agreed at the previous meetings that a more personal approach was required to fill the aforementioned vacancies and all members were asked to consider what they could do to progress the difficulty in appointments. Membership for 2025/26 schedule to be amended in light of the aforementioned membership changes.

ONGOING ACTION: ALL MEMBERS/CLERK

The Chair kindly summarised some of the aforementioned points and thanked members for their in-depth honest input on this really important agenda item.

#### 3. MINUTES AND MATTERS ARISING FROM THE MEETING HELD ON 10 FEBRUARY 2025

The Minutes of the previous meeting held on 10 February 2025, were **agreed** as a correct record.

**RESOLVED** that the agreed Minutes be uploaded onto the SACRE website and signed electronically as agreed on Governorhub by the Clerk.

**ACTION: CLERK** 

The Chair kindly reviewed the summary actions and the following items were raised out of discussion and members' questions:

(a) Minute No 2 – all SACRE membership details had been updated by the Clerk and would continue to be reviewed as and when membership details changed;

- (b) **Minute No 2(g)** the Constitution/TOR document presented at the last meeting and agreed was distributed to all members by the Clerk and uploaded onto Governorhub;
- (c) **Minute No 3** the Clerk had uploaded the minutes of 12 November 2024 onto the SACRE website;
- (d) Minute No.3(a) –Josh Newham briefly updated members on the RE Teach Meet session that had taken place and had some notes from the session. Following members' general discussion and interest, positive feedback had been received of the 12 Schools that attended, obviously it would have been better to have more representation from Schools, but 12 was still very good. For the benefit of new members and questions, the RE Teach Meet was a good opportunity for Schools to meet other subject leaders and RE specialists, share good practice and keep up to date with everything taking place in the RE world. Members discussed ways that Schools could pair up and network with others, which was a good way of developing teachers;
- (e) Minute No.3(b) following comprehensive discussion at the last meeting regarding sharing of resources/advice and guidance on collective worship, Tariq Sediq advised that he was just in the process of checking what resources were appropriate to share with staff and children and once happy with that was going to email the link details to the Clerk/Julia to share. The update shared by Father Vince Sheehan on the See Saw Online platform had been an excellent, powerful resource to be able to share work with the School community, some example reminders were pupil voice, collective worship and much, much, more. It was lovely to see the children using their oracy skills and being more creative, especially as some children struggled to express their views by writing them down. The videos were much more powerful in helping the children understand what was presented to them and helped remove some of the learning barriers. The Chair added that it was evidently a huge piece of work, which was greatly appreciated;
  - f) Minute No. 3(e) the Chair and Dr John Strange had attended a School visit at Freezywater St Georges School, which was thoroughly enjoyable and welcoming. It was lovely to sit in the classrooms and see the level of RE taking place at the School and how engaged the children were;
  - g) Minute No.9(a) the Clerk thanked those members who had kindly registered on Governorhub and had set up their username and password to access the site. There were still a few members outstanding and yet to set up their details. The Clerk advised members to expect an automated email message from Governorhub, which sometimes could end up in the junk file so to be aware of that. It was easy to set up and the Clerk was very happy to guide members through any difficulties. A subscription fee had been paid, and it had been agreed at the last meeting to use Governorhub as it was a very user-friendly resource platform for saving all SACRE meeting documentation in one central place.

#### **RESOLVED** that

(a) members who had not already registered on Governorhub to do so asap and contact Felicia Ferraro if they had any issues or difficulties.

#### **URGENT ACTION: MEMBERS WHO HAD NOT SIGNED UP TO GOVERNORHUB**

(b) Resources/U tube videos to be put together and forwarded to Julia Diamond-Conway, so it could be shared on the SACRE website for all Schools to easily access for advice and guidance in terms of collective worship and indeed any other information and guidance that members felt would be appropriate to share on that platform.

**ACTION: ALL MEMBERS** 

**NOTED** that all other actions had been duly completed as outlined above and there were no other matters arising that were not already being covered on the agenda.

# 4. FEEDBACK ON IMPLEMENTATION OF THE NEW AGREED SYLLABUS

**REPORTED** that this update had been deferred a few times, due to Josh Newham not being able to attend the meeting and apologies for the late update was provided.

Josh Newham kindly shared the update, and the following items arose out of discussion and members' questions/recommendations/challenge:

- a) a survey had been sent out to all Primary Schools only (not Secondary) to obtain feedback in what areas of the syllabus was and was not going well. Following discussion and interest, a survey could also be sent to Secondary Schools as well but Julia suggested doing it for KS5 first and then KS3. In response to a question, Humanist had been included in the syllabus;
- b) **for the benefit of the new members,** Saba Raza was a RE teacher and supported Schools with the RE training. She was very knowledgeable and supportive;
- Julia had also delivered some really good online training for the RE leads which was welcomed and evidently, they were not receiving the help that they needed.
   Comprehensive discussion took place in terms of clarification being sought for Schools that they did not need to cover the whole agreed syllabus;
- d) on a positive note, 80% of children enjoyed taking part in RE lessons and it made them think deeply of RE and the world views. It was appreciated the pressures that the RE teachers were under, especially in terms of planning (which really came out of the survey) and what the syllabus portrayed in working practice. In response to general interest, Lucy Nutt had contacted Saba Raza following the 90 responses received from the survey back on 12 August 2024 about what online training she could offer to Schools, as well as handover training for RE Subject Leads and whether they were able to provide training in their Schools once they had attended training. The School contact survey was also going to be emailed shortly to Schools, so hopefully they would provide their up to date RE email contacts. Following more in depth discussion, it was

suggested and agreed that September 2025 was a good opportunity to follow this support up and keep members up to date of further developments;

e) **following a question,** Lucy Nutt clarified that if Schools were not covering RE under the National Curriculum and there were areas of concern it was hoped that the LA would be approached to investigate and challenge areas as appropriate. The full Governing Body needed to then hold the School to account and so forth.

Josh Newham was thanked for his update to SACRE members. Any further questions were welcomed at any time.

**RESOLVED** that contact be made again with Saba Raza to enquire about the support she could provide as detailed above – point d).

# 5. GCSE INFORMATION

**RECEIVED** the following documentation, copies of which are included in the Minute book and available on Governorhub.

**NOTED** that Suzanne Rowson provided the following update to SACRE members and questions were welcomed.

- a) SACRE GCSE RE Analysis, School by School, course description, religion/component. Noted that AQA Syllabus – students answered questions on two religions, with the exception of Highlands School, all study Christianity and had selected Islam. All Secondary Schools responded with the exception of Aim Academy North, which did not provide any data requested by the LA generally. Suzanne Rowson guided members through the document and extracted some of the religions taught from the list;
- b) extract of GCSE RE Data Results 2023, School by School and by RE QAN (Qualification Accreditation Number). The extract was taken from the SACRE Annual Report 2023-2024 reviewed and discussed at the SACRE November meeting and action point rising. A breakdown of the results were examined and discussed. Generally the picture for Enfield looked positive. Following a question, the statutory hours of RE taught for Year 12 and 13 was 10. Some Schools organized RE days. Tariq distributed a copy of two Edexcel GCSE Papers 1 and 2. One for Religion and Ethics for Christianity and the other on Religion, Peace and Conflict: Islam. The concern highlighted to members was the image of how unhappy the child looked and the misleading title. Julia advised that any concerns about imagery content needed to be raised directly with the relevant Exam Board and then fed back to Lucy Nutt by SACRE, details were then included in the relevant SACRE Annual Report.

**Following members' comprehensive discussion and query,** Suzanne Rowson was asked if information on what Core RE in KS5 was taught in Secondary Schools for

the 10 hours allocation could be made available for the next meeting in November. Suzanne Rowson responded that she would try her best to obtain that information, however any other more detailed requests, for example what A level courses they were offering might be more difficult to find out.

- c) extract from current Enfield Agreed Syllabus detailing RE Statutory Requirements at
- d) the Statutory Requirements document was referred to and extracted on the next page for members' easy reference:-

# C8 RE in KS4 and 5 /14-19

# What do pupils get out of RE at this key stage?

All state-funded schools must teach RE to all students on school rolls, including all those in 14–19 education (unless withdrawn by their parents, or, if 18 or over, they withdraw themselves). It is important that teaching enables suitable progression from the end of Key Stage 3, in varied ways that meet the learning needs of all students. All students can reasonably expect their learning will be accredited, and **this agreed syllabus requires that all 14–16 students must pursue an accredited course** in Religious Studies or Religious Education leading to a qualification approved under Section 96 (see p. 15). The agreed syllabus does not require that every individual student be entered for this examination: that is a matter for schools. Appropriate modes of accreditation include nationally accredited courses in RE such as GCSE and A level RS, and a wide range of enrichment courses and opportunities, such as the Extended Project Qualification. Good practice examples include many schools where all students take GCSE RS courses at 16, since these qualifications are an excellent platform for 14–16 RE.

Note that teachers must ensure that RE in these phases accords equal respect to religious and non-religious worldviews. Following a GCSE course does not automatically fulfil this (see p. 16).

70 hours of tuition or 5% of curriculum time across Key Stage 4 is the normal requirement by which students can achieve the standards of the GCSE short course in Religious Studies. This is the minimum benchmark for RE provision at Key Stage 4 for schools using this syllabus. 140 hours of tuition is needed for GCSE RS Full Courses, in line with other GCSE subjects.

Schools should provide opportunities for those who wish to take A levels, alongside core RE for 16–19s. The minimum requirement is ten hours of core RE across Year 12–13.

The Chair summarised some of the points discussed and thanked Suzanne Rowson for the comprehensive update to members. Suzanne Rowson thanked Pauline Swain, the previous SACRE Clerk for the huge piece of work in extracting all the information presented.

**RESOLVED** that which Core RE in KS5 was taught in Secondary Schools for the 10 hours allocation be made available for the next meeting in November if possible.

#### 6. UPDATE FROM SACRE RE ADVISOR

**RECEIVED** a Summer term 2025 National RE update that was forwarded from Julia Diamond-Conway to the Clerk, which included details on RE CPD, networking opportunities and RE resources (see next page for full details).

Julia kindly guided members through each heading item and extracted specific areas of interest and information.

#### **Curriculum and Assessment Review**

The Government is conducting a Curriculum and Assessment Review, led by Professor Becky Francis. The review aims to examine how the curriculum and assessment system can better serve young people in England.

In November 2024, NATRE submitted over 100 pieces of evidence to the review, highlighting the current challenges facing Religious Education. Other key organisations such as the Religious Education Council of England and Wales (REC), NASACRE, and AREIAC also contributed, ensuring the review panel received a broad and well-informed set of perspectives from across the RE community. In its interim report (March 2025), the review panel wrote:

"Despite the fact that RE is compulsory for all pupils up to the age of 18 (unless they are withdrawn), evidence suggests that a lack of national agreed content standards has led to national disparities in the quality of provision."

This statement reflects one of the most persistent concerns in the RE community: that provision and quality vary significantly between schools and regions, depending on school or trust policy, local authority capacity, and interpretation of legal requirements.

The panel is expected to explore in more depth the causes of these disparities and consider a range of potential solutions.

Importantly, the Department for Education has confirmed:

"The terms of reference do not prevent the Review from making recommendations for national or basic curriculum subjects that might require legislation. Ministers will take decisions on what changes to make, and how best to implement them, in light of these recommendations."

This means that policy options such as:

- Including RE in the National Curriculum (currently it is part of the basic curriculum, which is compulsory but less regulated), and/or
- Introducing a National Content Standard for RE, possibly building on the widely welcomed National Content Standard developed by the REC,

are all still viable possibilities.

#### **New Curriculum Leader Secondary**

15<sup>th</sup> September (Full Day 9.30 am – 3.30 pm)

This one day course will introduce you to the role of the Secondary Subject Leader for RE and is suitable for newly appointed colleagues and those wishing to refresh their thinking about and delivery of this fundamental middle manager role. Covering areas such as development planning, analysis of outcomes and supporting staff you will come away with a wide ranging set of resources to support you.

Points/questions raised following the update shared by Julia were:-

- a) it was yet unknown what the Standards were going to look like, but there was speculation that it could potentially go into the National Curriculum but had yet to be confirmed for certain. It was very much looking out for further information when it was available;
- b) there was most certainly a challenge in terms of recruitment of RE teachers and teachers in general. There was also the difficulty and added pressure of ensuring that the teachers had the knowledge and skills to teach the standards. Members had a general discussion around some of the different reasons for appointing RE teachers;
- c) an ECT was an Early Career Teacher, originally known as an NQT, Newly Qualified Teacher, the terminology had simply changed;

- e) Tariq mentioned that places of worship could offer train the trainer sessions post September. Members agreed it was a point worth exploring further;
- f) particular reference was made to the BBC website resources and 3 minute clip for Primary Schools. Members were encouraged to explore the information further;
- g) RE Hubs this was a good platform to advertise new videos were on there which were very good and worthwhile checking. **Following a question from Dr John Strange,** Julia advised that it was best to contact the RE hub directly with any questions about registering as a RE speaker and what flexibility was on offer.
